

# Consent to the Processing of Personal Data

## Data Controller

## 1. Consent Text

### **By checking the box before submitting the registration**

in accordance with Article 6(1)(a) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter the “**GDPR (EU Regulation 2016/679)**”), which entered into force on 25 May 2018,

#### **4. Retention Period of Personal Data**

The Data Controller will retain personal data for the period strictly necessary. The maximum retention period is 12 months.

#### **5. How Will Personal Data Be Processed and Stored?**

Personal data will be processed:

by automated means (electronically) using computers and computer programs;  
in written form;

#### **6. Rights of the Data Subject, Information and Access to Personal Data**

As a data subject, I have the right to **access my personal data**, the right to **rectification or erasure** of my personal data, or, where applicable, **restriction of processing**. I have the right to request information on **what personal data is being processed** and the right to request **an explanation regarding the processing of personal data**.

I also have the right to lodge an **objection to processing**, as well as the right to **data portability** (i.e. the right to receive the personal data concerning me, which I have provided to the Data Controller, in a structured, commonly used and machine-readable format; see Article 20 of GDPR (EU Regulation 2016/679) for further details).

I have the right to **withdraw consent at any time**, without affecting the lawfulness of processing based on consent given prior to its withdrawal, where processing is based on Article 6(1)(a) or Article 9(2)(a) of GDPR (EU Regulation 2016/679). This means that such right does not apply where processing is necessary for compliance with a legal obligation to which the Data Controller is subject (obligations relating to accounting and tax records).

As a data subject, I have the right to request information about the processing of my personal data, which the Data Controller is obliged to provide without undue delay. The content of such information is governed by Article 15 of GDPR (EU Regulation 2016/679). The Data Controller may charge a reasonable fee not exceeding the costs necessary for providing the information.

As a data subject, if I have doubts about compliance with obligations related to the processing of personal data, I have the right to contact the Data Controller or the Office for Personal Data Protection.

The Data Controller declares that the processing does not involve **automated decision-making**, including **profiling**, as referred to in Article 22(1) and (4) of GDPR (EU Regulation 2016/679).

The Data Controller declares that personal data are not processed for the purposes of scientific or historical research or for statistical purposes.

The Data Controller declares that personal data will be processed:

by automated means (electronically) using computers and computer programs;  
in written form;

## 7. Final Provisions

As a data subject, I declare that I am aware of my rights under Chapter III of GDPR (EU Regulation 2016/679).

I declare that all data provided is accurate and truthful and are provided voluntarily.

The Data Controller declares that it will collect personal data only to the extent necessary for the fulfillment of the stated purpose and will process them only in accordance with the purpose for which they were collected.

This consent constitutes a freely given and informed expression of the will of the data subject, the content of which is the data subject's agreement to the processing of personal data.
